

MILLION DOLLAR FISH BOAT GIVEAWAY PROMOTION

CONDITIONS OF ENTRY

- Information on how to enter and prizes form part of these Conditions of Entry. Entry into the promotion is deemed acceptance of these Conditions of Entry. This is a game of chance.

ELIGIBILITY

- Entry is only open to residents of Australia ("Entrants"). The directors and management of the Promoter, its related suppliers, contractors and agencies whom are directly associated with the conduct of this promotion are ineligible to enter the promotion.
- 4. Entries are only open to people aged 18 years and above. All Entries (as that term is defined below) of Entrants who are under the age of 18 years and enter the promotion without disclosing (or who attempt to conceal) their age (as and where required) will be deemed invalid.

PROMOTIONAL DATES
